Some of the students who have completed the B.E./B.Tech./ B.Arch./MBA/MCA/ M.Tech./ M.Tech. (Part Time) programmes in full and failed in few subjects have represented to the University for an opportunity to appear for examination to complete their degree. The said representations were placed before the authorities of the University and on the approval of Executive Council vide above reference, the following is notified:

Four consecutive additional attempts are granted to the students who have completed all the course requirements with the conditions given hereunder:

- a) The following students who have completed the course in full [attended all **Eight** (B.E./B.Tech.)/**Ten**(B.Arch.)/**Four** (MBA/M.Tech./ M.Arch.)/**Six** (B.E./B.Tech. Lateral entry/ MCA/M.Tech.(Part time) semesters examinations at least once] and appearing for their backlog subjects.

- c. Examination Fee to be paid: Rs 2,000/- per subject per examination to the maximum of Rs. 6,000/- per semester for the students appearing for examinations under the benefit of this notification.
- d. This benefit is not applicable to the students those who have not completed the course in full.

The Principals are requested to instruct the concerned to be more vigilant while submitting the examination applications of the students under the benefit of this notification.
